# ECATS Reminders

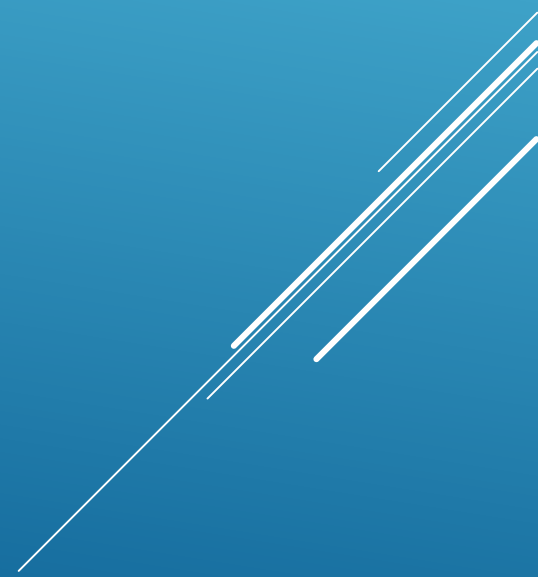
- ▶ AUG - Indicator 7 is due– LEA's are asked to complete Indicator 7 as they always have. Records to be submitted for Indicator 7 should be kept up with as the LEA's have always done. This indicator will close on 8/15/2018.
- ▶ SEPT - Exit Count is due- LEAs/Charters will need to complete as much as possible, all Exits for students in the 17-18 SY prior to 6/16/2018. Data Managers will also be asked to submit, complete, and certify a test count prior to 6/16/2018 so that any data corrections can be made.

# ECATS Reminders

- ▶ OCT - Indicator 11 is due- LEAs/Charters will be instructed to complete all referrals (if and as much as possible) for students referred in the 17-18 SY prior to 6/16/2018. Data Managers will also be asked to submit, complete, and certify a test count prior to 6/16/2018 so that any data corrections can be made prior to data migration.
- ▶ OCT - Indicator 12 is due – LEA's are asked to complete Indicator 12 as they always have. Records to be submitted for Indicator 12 should be kept up with as the LEA's have always done. This indicator will close on 10/12/2018 and data will be complete by 11/15. Charter Schools do not submit Indicator 12.
